Please review the rules below to ensure that your company does not exceed statutory annual limits.

Recommended contribution levels based on your company's annual volume of work or sales:

- \$1,000 (0-10 million)
- \$2,000 (11-20 million)
- \$3,000 (21-30 million)
- \$4,000 (31-40 million)
- \$6,500 (41-60 million)
- \$8,000 (61-75 million)
- \$10,000 (76+ million)

NOTE: The Build Indiana Council supports candidates for the Indiana House and Senate, caucuses in both houses, candidates for statewide and local offices, and state committees for political parties. Because all Build Indiana PAC funds will be used within Indiana, corporate checks will be accepted. Political contributions, including contributions to political action committees, are not tax deductible.

RULES GOVERNING CONTRIBUTIONS

Indiana law provides that individuals, as well as corporations and labor organizations, may contribute to political action committees. For individuals, there is no limit on the level of contributions. For corporations, aggregate annual limits are imposed as follows:

- \$5,000 among candidates for statewide offices¹
- \$2,000 among all State Senate candidates²
- \$2,000 among all State House candidates³
- \$2,000 for State Senate legislative party caucuses⁴
- \$2,000 for State House legislative party caucuses⁵
- \$5,000 among state committees of political parties
- \$2,000 among candidates for local offices; and
- \$2,000 among central committees other than state committees.

Corporate contributions to a political action committee must be designated to go to one or more of the above categories and are subject to the limitations in each category (IC 3-9-2-4). Therefore, a corporation may contribute a total of \$22,000 per calendar year either directly to candidates or through political action committees. Contributions to the Build Indiana PAC count toward these limits.
